



A5 – AQUANEUCE – WHITE WATER BASED ACRYLIC PRIMER (ANTI-STAIN)

DESCRIPTION:



This product is based on an acrylic emulsion especially prepared for walls insulation in interior or exterior, when a combined action is pretended, to insulate and to give a certain whiteness to the wall.

| SPECIFICATIONS: | Density |
| RECOMMENDED USE: | This is used as an insulation coat in the painting of sand-finish, and even stucco walls, before the application of the finish acrylic paint. This also allows to simultaneously insulate and give a certain whiteness to the wall, it is very used in the insulation of stucco interior walls. |
| SURFACE PREPARATION: | The surface has to be dry, clean, hard and free of bad-adhered particles or dirt. A good brushing is usually enough as preparation. |
| APPLICATION: | Before to use mix energetically the product. The application is made with a roller or a paint-brush in a single coat (well-uniformed) without any dilution. |





In the case of "poorly porous" walls it is advised a light dilution with water to guarantee a better penetration.

| DILUTION: | The "AQUANEUCE – WHITE WATER BASED PRIMER" is supplied ready to use. If necessary a dilution with water is possible. |

| COVERAGE: | Variable according to the support's absorption. On average and per coat 10 to 12 m^2 / liter. |
| CLEAN-UP: | With water right after the application. |
| ADVANTAGES: | In stucco walls of normal absorption, it doesn't "glaze." It allows a larger income of acrylic paints applied as finishing. As it insulates and simultaneously leaves the wall "half-white", it allows a better efficiency in the achievement of the final finish. |
| WARNING: | A selection of this product components has a tenor in clorometilisotiazolinona/metilisotiazolinona 3:1 inferior to 15 ppm, according to the Community Directive n°98/8/EC indications. <u>Hence this product is not irritant nor presents any risks of sensitization in a contact with skin.</u> In spite of presenting no risks for health, it is advised to keep out of reach of children. |
| STORAGE AND PACKAGING: | Packages should be kept properly closed, in good environmental conditions of temperature and humidity, and spend the product on the chronological order of supply.Use it, with preference, up to 2 years after its manufactured date, but it can also be used after this date, as long as a good homogenization of the product can be verified.It is supplied in packages of 11t, 51t and 15 liters. |
